Mid-America Mane Event Horse Show Check List

Eliminate incomplete entry fees. Utilize this check list as your guideline.

Welcome to the MAHSA show season! The check list below will help facilitate your entries. Back numbers will not be issued until all information is complete.

BEFORE YOU MAIL THE ENTRIES PLEASE REVIEW REQUIREMENTS BELOW:

- _____ All out-of-state horses/ponies (whether exhibiting or not) must have a current health certificate.
- _____ Proof of current owner registration (horse/pony). If ownership is **solely listed** as a **Farm or Business**, the Farm or business must have a **current competing USEF** card **or** pay the Show Pass fee and fill out the appropriate form.
- _____ Every horse/pony (whether exhibiting or not) must have a current Health Certificate, Negative Coggins for Equine Infectious Anemia within the prior 12 months and Proof of Rhinopneumonitis (Rhino/Flu) vaccination within 6 months of entering facility. See USEF RULE: **GR845 Equine Vaccination Rule**. *Find the entire document at: USEF.org/documents.drugsMeds/2016/2016GR08845VaccinationRule.pdf*
- _____ USEF Federation Entry Agreement – Three signatures on reverse side of entry blank.
- _____ USEF Waiver and Release of Liability – Signatures by everyone participating at this show.
- _____ Every owner, trainer and exhibitor who has a **current USEF competing** membership, must **also** have completed Safe Sport (Junior Exhibitors exempt). If you do not have a current USEF competing card you must pay the Show Pass fee and fill out the appropriate form. (Opportunity and Walk/Trot classes exempt). **For exhibitors in Amateur restricted classes, proof of USEF current competing membership and current Safe Sport is mandatory. No show pass fees are allowed for exhibitors in these classes.**
- _____ Proof of AHHS (Hackney) current membership for every owner and trainer.
- _____ Every owner, trainer, and exhibitor showing **Saddlebreds** must have a **current competing ASHA** card. (Opportunity and Walk/Trot classes exempt)
- _____ Every owner, trainer, exhibitor must be a current member of Mid-America Horse Show Association.
- _____ Current address for owner, trainer and exhibitor. Email address for trainer & owner (very important as this is how we can communicate changes and news releases to you regarding the show).
- _____ Every horse entered in a UPHA Classic must be currently nominated with UPHA. Every owner, trainer, **and exhibitor** must be current members. Every exhibitor in a UPHA Challenge Cup class must be a current member.
